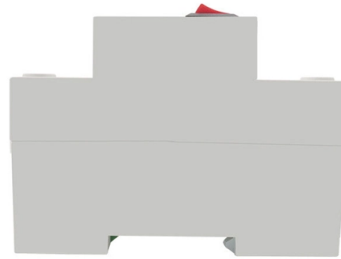


Latest Anti-dumping Investigation on Optical Cable



Overview

The investigation, initiated on October 3, 2023, found evidence of dumping by Indian exporters, leading to the imposition of duties on all Indian OFC manufacturers, except for HFCL and its subsidiary HTL Limited.
